Henry Brean—Las Vegas Review Journal



Henry Brean has done just about everything since he joined the Review-Journal in 2003 after nine years as a reporter and editor at the Pahrump Valley Times. He has spent the night on a mountain-top fire watch tower; taken a train 600 feet underground to a pipeline construction site underneath Lake Mead; handled peregrine falcon chicks for a short-handed researcher; and slithered head first into a cave behind biologists searching for undiscovered animal species. No one in Nevada—and maybe the world—has written more stories about tiny endangered desert fish.

Amy grew up in the Bay Area, then moved to southern Oregon to attend college and to work at her first newspaper, the Ashland Daily Tidings. She also worked as the lead

Rachel Aston—Las Vegas Review-Journal



For the six-month anniversary of the Oct. 1 mass shooting, Rachel Aston published a half-hour documentary that explored the trauma experienced by survivors of the tragedy. Her carefully edited piece weaves through the stories of six Las Vegans whose lives were changed by the heartbreaking event. She spent months earning their trust through repeated interviews so they opened up to her on camera, expressing feelings and memories that had never been published.

The video that accompanied the Review-Journal's story about local motocross racer Angie Wright is another great example of her work. Again, Rachel spent time with her source, finding opportunities to tell stories that went beyond the written word. She also took some terrific photographs that played well both in print and online.

Other examples of her high-quality work include a tearful

The Water Question: How long can the Colorado River sustain us?

With the Las Vegas Valley experiencing rapid growth and decades of drought shrinking its primary water supply—the Colorado River—the question of whether current resources can be stretched or additional water tapped to support future growth is not a hypothetical concern. It is existential.

With that in mind, Henry Brean, the Review-Journal's longtime land use and environment reporter, and Assistant City Editor Mike Brunner set out to paint a comprehensive picture of the challenges facing water managers and planners as they contemplate a future filled with question marks.

Brean's reporting soon made Review-Journal editors realize they couldn't do justice to such an important and complex topic in a single day. Eventually it was decided to make it into a seven-day series in order to offer readers in-depth looks at various aspects of the issue, including the history of how the state ended up with the smallest allotment of river water, the valley's impressive conservation efforts and the challenges facing planners trying to forecast water usage far into the future.

While Brean led the reporting effort, the scope of the package required a newsroomwide effort led by Brunner. Multimedia, graphics, design and interactive teams all played important roles in bringing the series to life.

The response to the Water Question recognized the more than six months of work that went into it. The Review-Journal received an outpouring of reader feedback and positive industry buzz.

Judge's Comment:

If this reporting and digital presentation doesn't prove just how existential water is to Las Vegas, as well as Nevada, I don't know what will. The in-depth reporting—on all sides of the issue—is commendable. In a time of newspaper cutbacks and reductions it's encouraging to see the Review-Journal supporting the financial requirements the staff needed to undertake six months of work to produce this first-rate series on water issues affecting Las Vegas.

Another year is too long to go without meaningful gun reform

From the editorial:

"A year after the Oct. 1 shooting, bump stocks remain legal in Nevada.

So do high-capacity magazines. So do assault-style weapons and tracer bullets. And all can still be purchased without a background check if the transaction doesn't involve a licensed gun dealer but instead is between unlicensed individuals.

In other words, not much has changed in terms of gun policy in Nevada one year after the worst mass shooting in modern history.

That's shameful. ...

As the community remembers the Oct. 1 shooting, one of many painful aspects of the anniversary is that Nevada has done nothing to limit the amount of deadly force that was openly available to the shooter that night. Nor has the state taken steps to keep weapons out of the hands of individuals who shouldn't have them.

Let's change that, voters. Let's honor the memories of the victims of our community's most horrific tragedy by making Nevada a safer place."

photographer at The Union Democrat in Sonora, Calif. and covered education at the Winchester Star in northern Virginia, before moving to Nevada.

She has developed a no-holds-barred reporting style, requesting records for political donations to show how the sheriff supported an anti-brothel initiative that he consistently refused to talk about on the record, and digging into the reasons why the fire chief resigned amid an ethics investigation—among many, many other topics. She also has brought in a diversity of voices to the paper's opinion page and developed freelancers to help cover community events. Without Amy's efforts, Lyon County would be a complete news desert.

Judge's Comment:

Alonzo is a nothing-flashy, just-the-facts reporter who scours public records and research reports to shine a light on hidden issues like rural homelessness, as well as high-profile local brawls like the effort to ban brothels in Lyons County. Especially enjoyed the story in which she cleverly juxtaposed campaign finance records and a local candidate's on-the-record statements, clearly demonstrating he deceived voters without having to say so explicitly.

A native of Tucson, Arizona, Brean also has covered every major development on the Colorado River in the past 15 years, often leading the region's coverage and improving its understanding of complex water issues. In addition to being named one of this year's two Outstanding Journalists, his 10-part series on the river and the future of Las Vegas' water supply won Story of the Year.

But Brean's work for the Review-Journal goes far beyond covering water. When a big story breaks, such as the 2017 mass shooting on the Las Vegas Strip, Henry is one of the first reporters editors call. He's an ace reporter and rewrite man capable of organizing a complex, rapidly changing story while making the copy sing. He also has served as the Review-Journal's de facto rural correspondent, traveling the state to report on brothels, the Bundy clan and other only-in-Nevada topics.

Judge's Comment:

Beautiful attention to detail. Depth and context throughout. Extremely accessible and interesting, the water series is well researched and informative, doing a public service in a region where residents NEED this information. Good pacing and excellent use of quotes in all of the stories. The variety of topics in his work demonstrates brightness and breadth in this journalist.

2019 HALL OF FAME INDUCTEES

C.J. Hadley



To appreciate her unique and notable role in the history of Nevada journalism, consider the fact that Caroline Joy Hadley, aka “CJ” Hadley, is the first person to be inducted into the Nevada Newspaper Hall of Fame without ever having worked at a newspaper.

For the past 28 years and 108 issues, Hadley has been publisher and editor of Range magazine, the only publication in the state that strives to document the trials, tribulations, failures, challenges and successes of those who live, work, love

and strive to preserve the spirit and heritage of The West.

She was born in England and emigrated to the U.S. when she was 17. She began her career as a journalist in 1963, in the New York magazine publishing world. Within a few years she was hired as managing editor of Car & Driver, where she remained until 1972.

A three-year stint traveling and writing adventure pieces for national magazines ended with a 1975 assignment for Sports Illustrated serving as commercial tuna fishing deckhand. “I thought I was a tuna fisherman,” she wrote, “until I puked 21 pounds of my own viscera into the Pacific.” After three weeks at sea she was dropped off on the docks of Sausalito, dehydrated and starving. She promptly hitchhiked to the driest state in the union, which she has called home ever since.

She served as editor of Nevada Magazine during the publication’s most formative years editorially and in

circulation growth. Under her watch, the magazine transitioned from quarterly to bimonthly frequency and became self-supporting for the first time in more than 30 years. There were bumps along the way, including the time she put her own health and the publishing life of the state-sponsored magazine on the line against powerful legislators who threatened its finances and her personally. She rallied community leaders who backed her up and shamed the legislature into retreat.

After leaving Nevada Magazine in 1985, Ms. Hadley freelanced for a number of publications and worked as a consulting editor for the University of Nevada, Reno Silver & Blue alumni magazine to earn the money she needed to launch Range magazine in 1991.

In the eight years Range has participated in the Nevada Press Association’s Better Newspaper and Magazine Contest it has been recognized with more than 120 awards, despite having no fulltime editorial staff.

In one of those competitions a judge remarked: “Never heard of Range magazine before but they take wide swings at big, fascinating, important subjects with thorough investigation, put-me-there drama and unflinching portrayal of the facts, regardless of politics, personal beliefs or religion. This is the kind of reporting that makes us important and relevant in an age when everything else is becoming more like a sound bite.”

Vail Pittman

Vail Pittman is the second Nevada Governor to be inducted into the Nevada Newspaper Hall of Fame, but the first to be a newspaperman before he was elected to public office.

Pittman was born in Vicksburg, Mississippi, sometime between 1880 and 1883, the youngest of four sons born to parents who died when he was an infant. He was raised by an aunt and uncle and spent his formative years in Louisiana. He attended the University of the South and

Brown’s Business College, but returned home in 1903 to manage the family cotton plantation after his uncle’s death.

He left Louisiana in 1904 to follow his brother Key, who had moved to Tonopah. Key was later elected to represent Nevada in the U.S. Senate, a seat he held for seven years until he died in office in 1940.

Vail Pittman initially entered the coal business in Nevada, and subsequently engaged in a variety of

occupations, including undersheriff of Nye County, sergeant-at-arms of the Nevada Senate, and partner in a mining company. Along the way, he met Ida Louise Brewington and they were married in Reno in 1919. He and his wife bought the Ely Daily Times the following year and launched what was to become a successful newspaper business.

Pittman’s political career began in 1925 when he was elected to the Nevada State

Holly Rudy-James

From the moment she arrived in Nevada, Holly Rudy-James was a strong advocate for rural newspapers in the state and a driving force within the Nevada Press Association at a time of transition for the organization.

Rudy-James came to Nevada in 2002, from Park City, Utah, where she had worked in the marketing department for several years at the Park Record. She had been hired by the company that eventually became Winnemucca Publishing to serve as general manager of The Humboldt Sun and The Battle Mountain Bugle. Five years later, Winnemucca Publishing purchased the Lovelock Review-Miner, along with a monthly periodical, The Nevada Rancher, and she was put in charge of the business operations of those papers as well.

With the purchase of the Review-Miner, Winnemucca Publishing’s coverage extended across the Tri-County area of northern Nevada. Local content was the mainstay of each newspaper with offices and local reporters in each community. Rudy-James oversaw a sales team that worked with businesses spanning the small communities of northern Nevada, offering a wide variety of printed media, including the three weekly newspapers, two monthly periodicals, specialty publications and two TMC direct mail pieces.

The company had a printing plant in Winnemucca, so Rudy-James’ sales team also worked with local businesses and governments to publish customized programs, handouts, newsletters and visitor-targeted newspapers.

Rudy-James worked to ensure that Winnemucca Publishing’s newspapers were viewed as valuable members of their communities, building relationships with local and county governments, non-profit organizations, schools, churches and religious groups. She oversaw several community projects, including a fundraiser for the Humboldt County bookmobile that raised over \$8,000. She also worked with organizations



in Humboldt County to collect items for needy seniors during the Christmas season, which led to similar projects in Lander and Pershing Counties.

Rudy-James joined the Nevada Press Association board of directors in 2006 and remained on the board until her retirement in 2016. She was elected president in 2008-2009, and was called to serve again in 2010-2011, to replace the late Mark Lundahl, who passed away only a couple of months after his term began. “I appreciated that she stepped up to lead the board and kept the press association functioning,” said Barry Smith, who was NPA’s Executive Director at the time. “So did the other board members. It helped maintain continuity and provide the leadership we needed.”

While on the press association board, Rudy-James worked with other members to build a statewide public notice website that aggregates all of the notices published in Nevada newspapers. She also hosted the annual convention and awards banquet in Winnemucca in 2009, at the conclusion of her first term as NPA president.

Rudy-James started her career in the 1970s selling yellow page advertising in Salt Lake City, where she was born and raised. She was the oldest of five siblings. She met her husband, Mike James, when she moved to Winnemucca. She has two sons and a granddaughter.

1ST AMENDMENT CHAMPIONS

The Nevada Press Association's highest legislative priority in 2019 was improving government compliance with the state's Public Records Act. The vessel for our aspirations was Senate Bill 287. The final version of SB 287 established penalties for local governments and state agencies that willfully violate the law; limited their use of excessive fees to discourage records requests; and added provisions requiring government employees to communicate with requestors and help them find the records they seek.

SB 287 passed both chambers unanimously in the final hour of the session and was swiftly signed into law by the governor. So it's only natural that our 1st Amendment Champions this year are the individuals who arguably had the most to do with its passage.

The honors begin with the Champion who was there at the beginning of the process. **Tod Story** started his work on SB 287 almost immediately after it became clear that the public records reform measure he supported in 2017 wasn't going to pass. He helped to draft the language included in the original version of the legislation. He was a co-founder of the Right to Know Coalition, an ideologically diverse coalition that activated grassroots support for the bill. And as executive director of ACLU of Nevada, he led the organization to fight alongside the Nevada Press Association in a number of other pro-transparency battles in the 2019 session.

Senator David Parks (D-Clark 7) was the primary sponsor of SB 287. In his role as chairman of the Senate Government Affairs Committee, he scheduled and facilitated the first hearing on the bill. When it bogged down in committee, he nurtured support for the legislation by asking **Senators Melanie Scheible** (D-Clark 9) and **Ben Kieckhefer** (R-Carson City, Washoe 16) to work with stakeholders and draft a compromise revision of the bill that could pass both chambers. Both Senators waded into the details of the legislation and worked diligently on a compromise. Perhaps most importantly, they resisted intense pressure from government lobbyists to water down their amendments. All three Senators were vital in getting the bill passed.

More than 1,100 bills were introduced in the 2019 session and with only four months to consider them it's inevitable that many never made it to the finish line. Aside from broad public support, what often separates the winners from the losers is whether political leaders are willing to prioritize a particular bill. **Assembly Speaker Jason Frierson** (D-Clark 8) made sure SB 287 was a priority in the final days of the session. His active leadership kept the bill moving in the session's final hours and ensured that public records reform had support in the Assembly.

Governor Steve Sisolak has long been an advocate

for open government. His insistence on government transparency as a Clark County Commissioner in 2011, helped to expose extensive overtime fraud being committed by county firefighters. He maintained that resolve in his first year as governor. SB 287 would never have passed if he hadn't conveyed

his support to legislative leadership. Moreover, his April interview in the Review-Journal, in which he noted that government agencies leverage excessive fees and immunity from punishment to deny legitimate records requests, helped to bolster public support for the bill.

Senate, where he served until 1929. He was elected lieutenant governor in 1942 and was a candidate in the Democratic primary for U.S. Senate in 1944, but was defeated by the incumbent, Pat McCarran.

Pittman became Nevada's 19th governor when Edward P. Carville resigned in 1945 to accept appointment to a vacant U.S. Senate seat. He was elected in 1946 to a term of his own and served until 1951. He ran for reelection in 1950 and 1954, but lost both times to Charles H. Russell, who had served as editor of *The Ely Record* for more than 15 years until he retired in 1946 when Pittman bought the rival newspaper and turned it into a weekly edition of the *Times*.

After leaving office Pittman and his wife returned to Ely and their newspapers before selling them both in 1951 to Donald W. Reynolds.

Pittman died from lung cancer on January 29, 1964 in San Francisco, California. He is interred at Masonic Memorial Gardens in Reno.

never having seen any of her photos, she credits her uncle, Dayton "Hawk" Hyde, a former rodeo photographer and bull rider, as inspiration. Hawk, who managed "lams" for several years, wrote several books about ranch life, including "Lams" and "Pastures of Beyond." Hyde says, "He captured my youth. A lot of the stories he tells are things I remember."

For years she joined friends for extended rides into wild and remote backcountry areas, including places that frightened her. "I've been horseback everywhere up in the mountains," she says, "including the rim of Crater Lake."

While her life away from ranches hasn't been picture perfect, Hyde prides herself on taking and selecting pictures that accurately document buckaroos and ranching. As she explains, "I take photographs that make people feel excited, like they're there. That takes some thought and care, and that's what I love to do. I like to celebrate the skills of the people I photograph while keeping the clear thought that the photos are not about me; they are about the people I photograph. I thank everyone for allowing me the great privilege of documenting their lives."

Lee Juillerat is a frequent RANGE contributor who lives in Klamath Falls, Ore. He is working with Jack Nicol, the former owner of southeastern Oregon's MC Ranch, on a book that will include Juillerat's 40-plus years of photos and stories about ranchers and ranching.

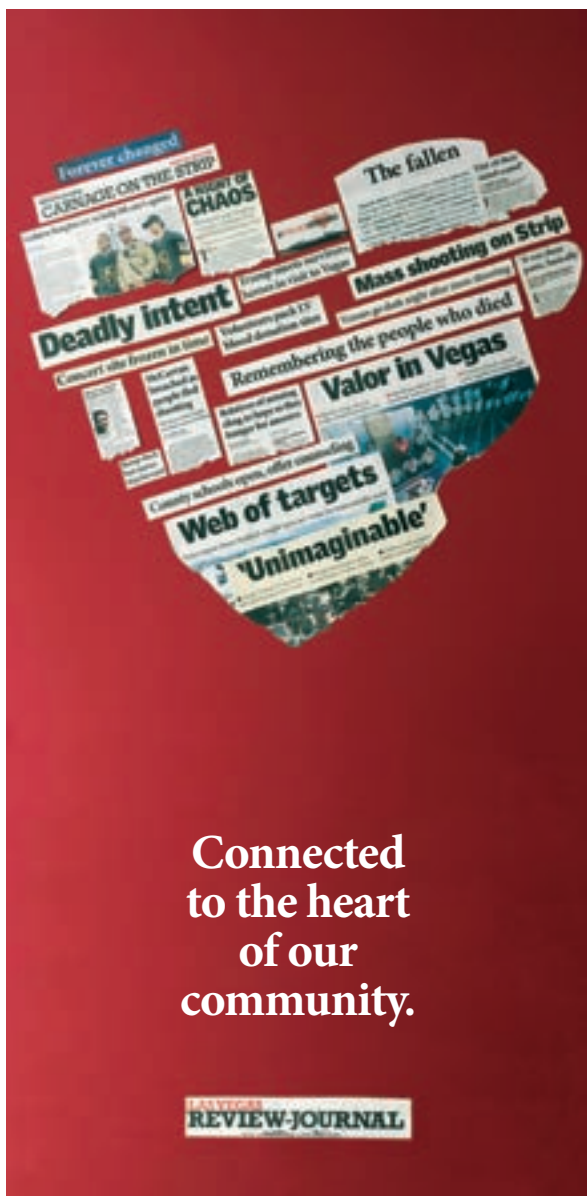

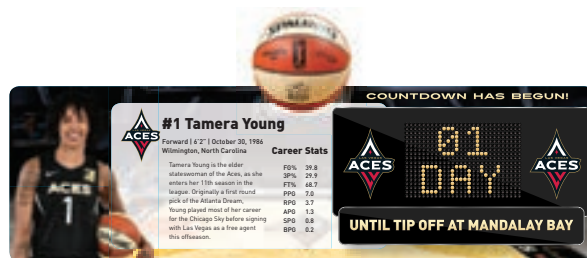

Interest rates and land prices are rising, as are rent costs. Ford notes that interest rates are expected to go up once more this year and twice next year. "In the last month, the 10-year Treasury note has gone up 10 basis points. Since January, it's 40 basis points," Ford said. "Though the payment differential may seem small, on monthly payments, it can be a fortune during the course of the loan."
For example, a \$1 million 25 percent down on a property that costs \$750,000, financing \$562,500, and the payment differential is \$202 per month, it will amount to \$160,000 during the 25-year life of the loan.
Even though interest rates are going up, it's still a good time to buy real estate. Rates are historically low, and buying gives you an advantage over competitors that are renting," Ford said.

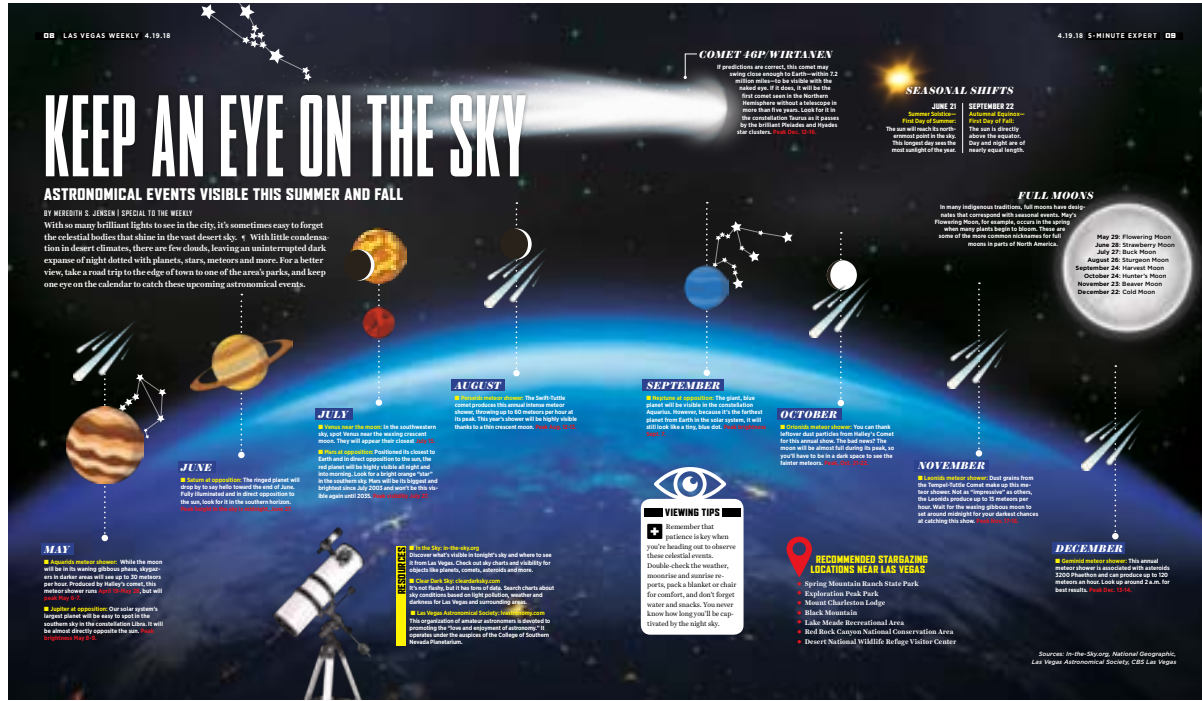

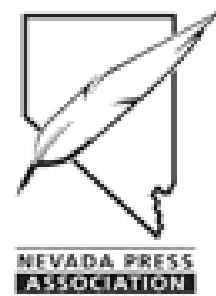
ABOUT THE JUDGES
