2020 HALL OF FAME INDUCTEES



DENNIS MYERS

A resident of Reno from age five, Dennis Myers cut a wide swath through Nevada media and politics. In the late 1960s, he attended the University of Nevada-Reno where he wrote for The Sagebrush student newspaper and covered the Nevada Legislature for Reno and Las Vegas radio stations.

For many years, he reported for KTVN TV-2 and KOLO TV-8 but his heart remained in print.

He was a Sparks Tribune staff writer and a contributing editor at Reno Magazine. He devoted the last 15+ years of his professional life to the alternative weekly Reno News & Review, where he became an awardwinning reporter and news editor.

In 2015, Myers and his colleagues received the Reno-Sparks NAACP's highest honor for their reporting on civil rights, human rights and police shootings, much of which went viral.

He continued as a contributor to the Las Vegas Business Press, the Pahrump Valley Times and many others.

A lifelong researcher, he coauthored "Uniquely Nevada," a children's history textbook, and contributed to the historical

volumes "The Mythical West" and "Covering the Courts in Nevada."

He always championed progressive values.

"Myers was as consistent a critic as any conservative when it came to Nevada's rampant corporate welfare proliferation and increasingly regressive taxation," wrote his friend and fellow journalist Andrew Barbano. "He was a champion of the rights of workers, unions, minorities and women."

Myers also took a couple of brief detours into politics. In the mid-70s, he served as state chair of the Nevada Young Democrats and was a Democratic nominee for a Reno state senate seat in 1976. He also briefly left journalism in 1987-88 when Secretary of State Frankie Sue Del Papa appointed him as her chief deputy.

Myers became a U.S. Army military policeman while serving in Europe.

He never stopped being a policeman, speaking "truth to power," the title of the News & Review cover story about his life.

He died in August 2019, at the age of 70.



NELLIE MIGHELS DAVIS

Nellie Mighels Davis was the first woman to cover the Nevada Legislature, reporting on the assembly in 1877 and 1879, when her husband Henry Rust Mighels owned the Nevada Morning Appeal. When he died in the spring of 1879, Nellie assumed ownership and took over as publisher of the Carson City paper at the age of thirty-five.

She hired Samuel Post Davis as editor; they were married the following year on July 4. Davis assumed management of the paper after the wedding and the family retained ownership of the Appeal until 1945, when Nellie died at 101.

One of her seven children, Henry R. Mighels Jr., was named editor of the Appeal in 1898 and remained in the position for at least 30 years.

In 1897, Mighels Davis also became

the first woman ever to report a prize fight, when the Corbett-Fitzsimmons fight was held in Carson City. Nevada was then the only state in the U.S. where professional boxing was legal. She was paid \$50 for the story by a Chicago newspaper. "I was for Fitzsimmons and I had a bet on with Mr. Woodburn," Mighels Davis recounted. According to the Nevada Women's History Project, she was one of only a few women-mostly prostitutesin the audience. She used her maiden name on the story to avoid "disgracing" herself and her friends by revealing she had been present at the fight.

In 1899, during the Spanish-American War, Mighels Davis organized the Red Cross in Nevada and became the first State President.



DON DIGILIO

Don Digilio was employed at the Las Vegas Review-Journal for more than 20 years, working his way up from reporter and columnist to become the paper's top editor in 1969. According to the Online Nevada Encyclopedia, Digilio "returned stability" to the Review-Journal newsroom during his tenure as editor.

"Don fit the times in Las Vegas perfectly," said fellow Nevada Newspaper Hall of Fame member and former Review-Journal journalist Tim Dahlberg. "He was the editor of the paper but he was

also the face of the paper and a mover and shaker in a town where moving and shaking was an art form. He wrote about the news of the day in his columns, of course, but what he excelled at was being funny in print."

Digilio's career at the Review-Journal ended in 1980, when he was forced to leave after he was offered stock options in a casino that was never built. He later resurrected his newspaper column in both the Valley Times and the Las Vegas Sun, where he originally

THOMAS MITCHELL

Thomas Mitchell has a lifelong record of outstanding journalism, distinguishing himself as both an editor and columnist. As the newsroom leader of Nevada's largest newspaper for two decades, he also did as much as any other journalist in the history of the state to defend and expand public access to government records.

Mitchell started his journalism career in 1973, at a daily newspaper in suburban Ft. Worth, Texas, where he was named city editor only six weeks after taking a job as a reporter. He was night city editor of the Miami News, when that newspaper closed in 1989, and joined the Las Vegas Review-Journal as its managing editor later that year.

"Las Vegas needed new blood, and I was intrigued by the management experience he already had," said Sherman Frederick, then editor of the Review-Journal, who hired Mitchell to help lead the newsroom. freelancer. Until recently, Mitchell Mitchell became the paper's top editor three years later, when Frederick was named publisher.

Mitchell assigned reporters to stories long neglected in a city with a tradition of letting sleeping dogs lie. He demanded and published public payroll information,

previously considered untouchable. He devised the Review-Journal's Judicial Performance Evaluation, a groundbreaking and influential survey in which attorneys are asked to rate judges. And he personally supervised and expanded a special projects team that not only did investigative reporting but also took on unusual projects too timeconsuming for reporters covering daily beats.

The paper also aggressively pursued information the government wanted to conceal, filing more than 20 court challenges during Mitchell's tenure. They resulted in several groundbreaking rulings, including one in which the Nevada Supreme Court decided that government officials' cell phone bills are public records.

Both Mitchell and Frederick left the Review-Journal in 2010. When Frederick co-founded Battle Born Media, he hired Mitchell as a wrote most of the editorials and a regular column for the company's mostly rural newspapers.

Mitchell was president of the Nevada Press Association in 1999-2000 and he has won too many awards for column and editorial writing to list in this space.

CORY FARLEY

Cory Farley has been one of the luminaries of Northern Nevada journalism, appearing regularly in print since 1981. His easygoing, comfortable prose quickly established him as one of the Reno Evening Gazette's top news feature writers, and his subsequent left-ofcenter column writing has made him one of the most-read writers that Nevada journalism has ever produced. His writing has sparked conversation among newspaper readers in the region for decades.

He came to journalism late in life and completely by happenstance. After flunking out of college, Farley went into the Army and did a tour in Vietnam as a Special Forces medic. When he returned, he registered for college again at the age of 23, and when the girl next to him in line selected journalism as her major, he decided to do the

It turned out to be a propitious decision. Farley enjoyed writing and did it well. His first journalism job was at Hot Rod magazine in Los Angeles, an ideal gig for a writer who loved cars. After working there for about a year, he came to Nevada

by way of Autoweek magazine, then published in Reno. When Autoweek was sold and moved to Detroit four years later, Farley stayed in Reno and joined the Evening Gazette as a part-time photographer.

"I came across a few decent stories while taking pictures, and (Evening Gazette Executive Director Everett) Landers, encouraged me to do an occasional op-ed and opinion piece," explained Farley. "That gradually turned into a weekly column, and when a job opened up in 1981 in what were then still called 'the women's pages,' I got it."

He enjoyed writing features more than news, and aside from a year on the news side and a short tour on the copy desk, Farley remained in the feature section until he retired in 2007. The column had been published more or less continuously, sometimes weekly, sometimes weekdays and Sundays, usually three or four a week, for 26 years. He continues to occasionally write opinion pieces published in the paper now know as the Reno Gazette Journal.

"If I could go back and start over, I would," he told us.

began his career as a reporter after arriving in Las Vegas in 1958.

He was president of the Nevada Press Association in 1976-77.

When he was at the Review-Journal, Digilio's relationship with Frank Sinatra, Las Vegas' then-most famous denizen, was so fraught his friends had to arrange a "peace talk" in Sinatra's dressing room at Caesars Palace. Digilio was the first to report in July 1966, that Sinatra was marrying Mia Farrow,

and later broke the story about the singer's sudden departure from his most famous haunt, the Sands, and the tantrum and fisticuffs that precipitated it.

He was born in Omaha, Neb., where his father ran two cigar stores and pool halls. After graduating from the Univ. of Nebraska in 1956, he served with the Eighth Army in post-war Korea, then was transferred to Tokyo, where he worked for Stars and Stripes.
