

2022 Hall of Fame Inductees

Tom Tait



Tom Tait was a Las Vegas-based Associated Press news editor who hired reporters, mentored writers and guided coverage in Nevada and surrounding states from 2000 to 2022.

He retired in June 2022 as Southwest AP news editor for Arizona, New Mexico and Nevada after 45 years in journalism in California and Nevada.

The roster of reporters Tait managed speaks volumes. He

joined a Nevada AP staff of names familiar to Nevada Press Association members, including three who are Hall of Fame members: Robert Macy, Tim Dahlberg and Brendan Riley. He also hired or guided dozens of gifted AP journalists, including Pulitzer Prize winners Adam Goldman and Hannah Dreier.

"I think a news editor can be measured by the quality of the report and the character of the people they enlist for the job," said Ken Ritter, a longtime AP news reporter who worked with Tait for almost 25 years. "The roster of reporters Tom has managed speaks volumes."

Tait edited the Spartan Daily at San Jose State University in the 1970s. He worked at the

Bob Brown



Brown made his most significant contribution to Nevada journalism as owner and publisher of the North Las Vegas Valley Times from 1973 to 1984.

He bought the paper from former Las Vegas Sun managing editor Adam Yacenda and two years later turned the weekly paper into a daily. At the time, it made Las Vegas the only city aside from New York with three daily newspapers. Competition with the Sun and the Las Vegas Review-Journal was intense, but the Valley Times forged a unique path, revolutionizing coverage of politics and gaming in the state, focusing on the business of the gaming industry and on organized crime.

"He turned (the Valley Times) into a must-read publication for politicians, business people and gamers, even though by 1979 its circulation (was dwarfed by its competitors)," wrote Jane Ann Morrison in the Review-Journal.

Brown assembled a talented staff of reporters, including eventual Nevada Newspaper Hall of Fame members Ned Day and A.D. Hopkins. Day had unparalleled sources in law enforcement and organized crime, enabling him to uncover mob influence in the

Steve Carp



Steve Carp has covered many of the biggest events and personalities in Las Vegas sports history.

For the Las Vegas Sun, he reported on the University of Nevada-Las Vegas mens' basketball national championship run in 1990 and return to the Final Four in 1991. He was the Las Vegas Review-Journal's lead writer for the expansion season of the Vegas Golden Knights during the team's march to the Stanley Cup final. And he was the paper's lead boxing writer at the height of Floyd Mayweather Jr.'s career, covering all of the major fights held in Nevada during that period along with the boxing careers of world champions Manny Pacquiao, Oscar De La Hoya, Canelo Alvarez, Gennady Glolovkin, Shawn Porter, Jessie Vargas and Ishe Smith.

Carp reported on the 2007 NBA All-Star Game and the first 12 years of the NBA Summer League, as well as the Hall of Fame career of tennis great Andre Agassi. Las Vegans also learned about college and professional football, baseball, golf and soccer, including the 1994 World Cup, from Carp's reports.

The Brooklyn native moved to Las Vegas in August 1988 to work at the Sun. He joined the Review-Journal in 1999 and left the paper in 2018 to serve as senior editor of Gaming Today, where he managed a staff of 32 writers. He helped the weekly become an award-winning national paper that covered the growth of sports betting outside of Nevada, as well as the casino industry and Las Vegas entertainment scene.

Earlier in his career, Carp worked

Los Angeles Herald Examiner, the Camarillo Daily News, the Daily Pilot in Costa Mesa and the Orange County Register before spending nine years managing and editing The Desert Sun, a Gannett newspaper. He became AP news editor in Las Vegas in February 2000.

Tait's name wasn't in the byline. But his imprint was everywhere in the AP report.

He oversaw coverage of elections; the aftermath of the Sept. 11 attacks in 2001; entertainer Roy Horn's mauling in 2003 by a white tiger at The Mirage; the 2006 shooting death of a judge in Reno; the 2007 arrest of O.J. Simpson and his trial, conviction and release in Lovelock in October 2017 – the same day a gunman killed 58 people in the deadliest shooting in modern U.S. history on the Las Vegas Strip.

There were corruption scandals, casino implosions and openings; the effects of the Great Recession of 2008; the Sagebrush rebellion and an armed standoff at the Bundy ranch; shootings of a judge in Reno in 2006 and at an iHOP restaurant in Carson City in 2011; the long political fight before the federal Yucca Mountain nuclear waste project was shelved; the rise and fall of water levels at Lake Mead; and the coronavirus pandemic and casino closures in 2020. ■

Jane Ann Morrison



Jane Ann Morrison worked for four newspapers over 48 years and during 44 of those years she was based in Las Vegas, reporting on everything from the mob to gaming and politics.

She arrived in Vegas in 1976 to work for the Review-Journal, where she reported on-andoff for 38 years. She started as the night cops reporter, wrote magazine features and became the newspaper's federal court reporter around the time the FBI began focusing on bringing down the Las

gaming industry.

Unfortunately, three dailies in the same city became financially untenable and when the Valley Times ran into trouble Brown got involved in an advertising scheme that allowed mob figures to launder money. After he was caught, he said he did it to keep the paper alive.

Brown also stopped paying taxes. In 1982, the IRS seized the Valley Times' assets to cover \$200,000 in back taxes, leading the paper to declare bankruptcy. Brown was indicted on tax charges and pleaded guilty in 1983.

Shortly before he died at the age of 54 in 1984, Brown testified against a participant in the moneylaundering scheme. The prosecutor later wrote, "Brown has devoted a large measure of his life to the public affairs of this state when any number of other pursuits Vegas mob.

Morrison wrote about then-Gaming Commission Chairman Harry Reid during this period, when Reid publicly beefed with mobsters like Frank Rosenthal. She also covered Oscar Goodman when he was a lawyer for mob enforcer Anthony Spilotro and wrote many columns about his mayoral days. She was the first to confirm that Rosenthal was a government informant, although Goodman consistently denied it.

Writing about political corruption and gangsters like Spilotro and Rosenthal turned out to be perfect training for becoming the Reno Gazette-Journal's Las Vegas bureau chief in 1986. She also covered the 1987 and 1989 Nevada legislative sessions for the Gazette-Journal, which prepared her to become the Review-

would have been easier and more financially rewarding."

Brown served as editor of the Review-Journal from 1961 to 1964, when he resigned over a dispute with the owner regarding political coverage. After leaving the paper, Brown worked briefly as a speechwriter for then-U.S. Senate candidate Paul Laxalt.

Two years later he moved to Tucson to serve as the first editor of a new paper, the Tucson Daily American.

Brown was also a correspondent in Asia for UPI, worked as a journalist in Alaska and Arkansas, and served as editor and publisher of the Lacey (Wash.) Leader. He also served as a chairman of the Nevada State Tax Commission.

Brown was posthumously honored as a Distinguished Nevadan by the Nevada System of Higher Education.

Journal's political reporter when she returned to the paper in 1990. In the early aughts, she reported on Clark County Commissioner Dario Herrera's shady dealings and juicy contract with the Las Vegas Housing Authority even before it was revealed the FBI was investigating him for taking bribes.

Morrison became the Review-Journal's first female general interest columnist in 2003 and wrote about everything from politics, the mob and corrupt politicians to hoarders, cookies and coloring her hair for the first time.

Her columns were deeply reported; when she found a topic that interested her she stuck with it. One of her crusades led the Nevada Board of Medical Examiners to put disciplinary actions against doctors back on its website after the board had removed that information. Sometimes she failed. Her advocacy for appointing rather than electing state judges didn't persuade voters.

In 2014, she cut back from three columns a week to one before completely retiring in 2018.

Morrison began her career in 1971 as a "copykid" for the Christian Science Monitor in Boston. Two years later she moved back to her birthplace, Fort Smith, Ark., to work for the Southwest Times Record, where she covered everything from cows killed in the road to Bill Clinton's failed run for Congress.

She was also the only one in the newsroom the day former South Vietnam Prime Minister Ng Cao Ky was spotted eating lunch at a hotel coffee shop by the paper's publisher. She rushed to interview Ky and ended up accompanying him to Fort Chaffee. ■

Carp has too many journalism awards to fit in any reasonably sized basement. He is already a member of two other Halls of Fame — the U.S. Basketball Writers and the Southern Nevada Sports Hall of Fame. He was named Nevada Sportswriter of the Year six times by the Nevada Sports Media Association, and has won numerous writing and reporting awards from the Nevada Press Association, Sigma Delta Chi, the Society of Professional Journalists and the Associated Press Sports Editors. His work has also appeared in national publications, including Sports Illustrated, The Sporting News, Basketball Times, The Hockey News and Street & Smith's.

He is the author of two books — "Vegas Born: The remarkable story of the Golden Knights" and "Runnin': UNLV Rebels – A Basketball Legacy." ■


